- Amendment under 'Meetings and Events': from 'chaired' to 'facilitated'
- The Network members endorsed the draft terms of reference on a consensus basis.

Lobby for review of the Planning and Environment Act (1987)

- Focus on planning and housing for growth and liveability.
- Increased focus on infrastructure planning
- Councils

Transport infrastructure

- Focus on rural as well as regional.
- Bus connectivity (as per 2014 VAGO report on Coordinating Public Transport)
- Cycling infrastructure: (10% of state budget, requires further research).
- Accessible tram stops and bus shelters
- Electric vehicle charging points lobbying government to support

Transport service

- Planning services for population growth.
- Minimum service standards (e.g. frequency)
- Mandating services to major activity centres
- Recycling and a circular economy
 - Waste management
 - Supporting actions for a circular economy
- Decentralisation
 - Innovation around telecommuting for regional and rural development. Regional business hubs
 - Rural and regional working with interface councils to look at decentralisation
 - Service addition internet, community services, identifying and then filling the gaps
 - Fast trains out of regional cities
