### Feb – May report

1. Planning and Environment Act – lobby for review

VLGA has contacted a number of stakeholders gauging their views on the current P&E Act, including council planning staff, Committee for Melbourne, RMIT, Victorian Planning Authority, Infrastructure Victoria and staff from DELWP. We are currently in discussion with RMIT to scope out a possible research paper highlighting the deficiencies of the current Act. This paper will be the start of our lobbying efforts to the Minister for Planning for a review of the Act.

### 2. Waste and recycling

The VLGA has made a formal submission to the Planning and Environment Committee inquiry into waste and recycling. Thank you to all councils that contributed to the submission. The submission will be uploaded to the VLGA website. The VLGA has also requested a hearing from the Committee.

### 3. Infrastructure

The VLGA, in collaboration with the City of Wyndham, will host a one-day symposium on Friday July 5. The symposium is titled Building Communities: From challenges to solutions. Invitations have been sent to the Minister for Local Government, as well as CEOs of the Victorian Planning Authority (VPA) and Infrastructure Victoria. The State government has announced a review of the rating system for local government (part of its election commitment). The terms of reference for the review is attached to the meeting agenda. The review will be done via an independent panel process, similar to a planning scheme amendment panel process. At this stage, only the chair of the panel has been appointed, Dr Kathy Alexander (ex-CEO of City of Melbourne). The VLGA has contacted the review team offering our services for consultation with our members through a roundtable.
