Schools & Early Years: Acknowledgment of Work Driving System Change in Education

The HART Awards are a partnership between the Victorian Local Governance Association (VLGA) and Reconciliation Victoria (RecVic) supported by Bank Australia and Local Government Victoria (LGV). The awards recognise local governments and community organisations that are Helping Achieve Reconciliation Together - Aboriginal and non-Aboriginal people working together to build relationships, respect and understanding and demonstrate a commitment to Aboriginal self-determination.

The winners will be announced on 5 June during Reconciliation Week. Due to COVID-19 the Awards Ceremony will be deferred until later in the year.

These Awards recognise Victorian initiatives that contribute to local reconciliation outcomes. Finalists include initiatives that demonstrate Aboriginal and non-Aboriginal people working together, and initiatives that have contributed to building relationships, respect and understanding.

Winners will each receive a prize. The community group winner and the schools and early years winner will also be awarded \$1000 to support their reconciliation initiatives.

The short-listed and winning initiatives will be profiled in a booklet and promoted on the websites of Reconciliation Victoria and the VLGA, to provide inspiration for other organisations and communities.
