Acknowledgement of Country Welcome and Introductions	Claire welcomed members to the meeting and acknowledged the traditional land owners. Brief round table introductions.
Children's Voice Initiative - Slideshow "Why should adults listen to children?" Video features from Cardinia Shire and City of Casey, Literacy Friends program from City of Port Phillip. - Top 5 responses	 Background: The Victorian CFCC Network upholds the universal right of all children to be heard and participate freely in their community. At times, it may be difficult for adults, organisations and communities to grasp why listening to children is important. Earlier in the year the CFCC Network decided to help adults understand why they should listen by asking children one simple question: <i>Why should adults listen to children?</i> To capture a broad range of voices from children across cultural demographic and geographic areas in Victoria – all Network members were invited to pose the question to their communities of children and young people, and share the responses. The voices of children during Children's Week, October 2019. A slideshow was presented, summarising how the children and young people answered. <i>See attachment 1: powerpoint presentation.</i>. A survey was created to capture the responses. 120 responses were received in total. The top 5 reasons cited by children as to why adults should listen by listening to us

Celebrating Children's Week - Discussion: What did you do in your organisation to celebrate children's week?	Cardinia – students were asked to write 2 minute speech as part of a leadership day. Video shown of snippets of students speeches on the day. Casey – quite a large family children and youth department spanning ages 0 -25 years. Officers went out to their community and discussed with groups of children from playgroups to youth services. Childrens voice is part of new department strategy to guide them through the next 3 years (very important to their programming and planning over the next 3 years). City of Melbourne – all departments that work with children came together for a calendar full of free activities – promoted on What's On Melbourne, culminating in an Art Play session – old toys were collected, children reinvented them into new toys. Child safe standards was also promoted through internal messaging to staff. Ballarat - employed a consultant to coordinate a calendar events. The final Saturday was a family event held at an animal park, 150 vouchers for discounted entry were provided to vulnerable families. Brimbank – picnic in the park during the week, transport was provided to collect children from their playgroup centres to the picnic. Knox – drop in space at shopping centre – staff provided information to help parents access early years centre. Slideshow of children's answers to "why should adults listen to children" was shown on screen at drop in space. Monash – family fun day for children up to 5 years. Also during the regular school visits the Junior Mayor group were able to ask Councillors questions. Found that some parents don't even know it is Children's Week is or what it is about so week also drew attention to theme and purpose.

	Moreland – family picnic organised in partnership by one of neighbourhood house at neighbourhood reserve. About 300 children attended.
	Banyule – worked with Sustainable Macleod Inc. Volunteers organised veggie picking and planting.
	Cardinia – free fruit for children at all MCH clinics, home visiting nurses. Healthy lunch tip sheets. Dietician attended supported playgroup.
	Whittelesea – sensory play experiences at a park and surveyed families on parenting experiences. Partnered with a community health service – tapped into story times, family day care playgroup – plus education on nutrition.
Guest speaker Jaimee – Grade 6 Student from Pakenham - Why should adults listen to children? - What being child friendly means? - CEO for a day! Jaimee shared her experience as a CEO of Cardinia for the day.	Jaimee presented her ideas on why adults should listen to children – and explained that children are the future, because they have different perspectives, they are the citizens of both Cardinia and the world. Having a big imagination is what kids are good at. Adults need to understand how we see the world – imagine the world as a giant puzzle, sometimes you need a different perspective to be able to put the puzzle together. Most importantly children have the right to say what they think. Being child friendly means children are included in decisions Councils make – they might actually surprise you with ideas they have. Jaimee then shared her experiences as a CEO of Cardinia Share for the day, shadowing CEO Carol Jeffs. Activities she took part in included: - Touring My Place – a local youth facility - Visited local supported playgroup

	feel heard, they are not going to keep trying to communicate.
	Students spoke about their involvement in the SRC and how
	they work to make the school better. Examples included
	improvement to the bike track, having a bike rack attached to
	school bus to allow for bike rides beyond the school, and
	organising a footy day. They surveyed their peers about their
	favourite activities at the school, collated the responses and
	worked with the school to implement more of these
	activities.
