Victorian Local Government Elections October 24, 2020

The Victorian Local Governance Association (VLGA) acknowledges the recent announcement by the Minister for Local Government, the Hon Shaun Leane, confirming that the Victorian local government elections will proceed in October says Cr Lambros Tapinos, President of the VLGA.

However, despite the significant governance responsibilities of councillors to set the budget and strategy for these multi-million-dollar businesses, voter participation in local government elections in Victoria is lower than any other level of government. Kathryn Arndt, Chief Executive Officer of the VLGA, cannot overstate the importance for those eligible to vote in local government elections to ensure that they are enrolled to vote by 4pm on 28 August 2020 and participate in these elections. She encourages voters to cast their vote in an informed way – and understand the responsibilities the candidate they are voting for will have. It is important that voters scrutinise candidate statements and ask questions. After all, says Ms Arndt, we only get the elected representatives we vote for.

Cr Tapinos says potential candidates are encouraged to attend the VLGA's candidate information sessions that outline what it is to be a 'councillor'. The *Local Government Act* 2020 requires that all candidates intending to nominate for election must complete a mandatory online eLearning module prior to nominating. Amid COVID-19 and the introduction of a new Local Government Act, now more than ever, Victoria needs councillors with community standing as well as financial, organisational, and political acumen. So candidates need to fully understand and appreciate these responsibilities when they nominate to be considered for election.

The scope and responsibilities of Victorian councils are legislated for under the *Victorian Local Government Act 2020* – they are essentially a creation and extension of the state. And, despite the often ill-informed opinion that the business of local government is limited to or should be limited to *roads, rates* and *rubbish* – the fact is the responsibilities are far reaching and complex and, as a result, the role of a councillor is not simple.

Local government plays an integral role in connecting and caring for people and communities, which is clearly evidenced by state and federal levels of governments delegating the delivery of critical services to local government. It is the grass roots level of government and closest to the community.

If considering nominating as a candidate in local government elections, Cr Tapinos states that it is important to understand as much as possible about the role's responsibilities and the regulatory environment in which it operates. Once elected and when entering the council chamber, a councillor will be required to make decisions regarding multiple issues which will impact the entire community.
